# BERTHING TERMS AND CONDITIONS

## GENERAL DEFINITIONS | APPLICABLE TO PRIVATE AND COMMERCIAL VESSELS

- All rates quoted are in AED and are inclusive of 5% VAT.
- Catamarans and house boats are charged at 1.5 times the standard rate.
- The above rates are subject to a 20% surcharge for all commercial vessels.
- Berth fee is determined upon size of vessel or berth length depending on which is greater.
- Vessel size is the overall length including tilted outboards, bowsprits and swim platforms as stated on the boat registration or measured by Royal Yacht Club of Ras Al Khaimah.
- Berth size is the maximum LOA of a vessel that the berth can accommodate.
- Berth holders must ensure that Royal Yacht Club of Ras Al Khaimah is kept up to date with all current documents related to the vessel or the berth holder.
- Berth holders must notify Royal Yacht Club of Ras Al Khaimah if they are planning to or have sold their vessel.
- Purchasing an existing private vessel in the Marina and converting it to a commercial vessel without prior approval is strictly prohibited. Any attempts in converting a vessel will result in the Berthing Agreement being void and immediate removal of the vessel.
- For commercial vessels, capacity includes passengers and crew of the vessel as per its official registration.
- Utility consumption (power and water) is metred and charged monthly based on consumption, as per FEWA rates and service charge.
- Berth holders are subject to a three (3) month penalty for termination of all Berthing Agreements.
- In case of non-renewal of an Annual Berthing Agreements, the vessel shall be subject to visitor berthing fees for the duration of the stay following the Berthing Agreement end date.
- All rates, charges and fees, includes increases in fees made by government or municipal department charges, are subject to change at Royal Yacht Club of Ras Al Khaimah's discretion.
- Berthing fees, terms and conditions are subject to change at Royal Yacht Club of Ras Al Khaimah's discretion.

# BERTHING TERMS AND CONDITIONS

## PAYMENT TERMS

- Payment must be made in full prior to commencement of the Berthing Agreement with one of the following options
  - Cash in full
  - Card in full
  - Cheque in full
  - Bank transfer in full
  - One current dated cheque and five (5) post-dated cheques

## POST-DATED CHEQUES

- Post-dated cheques are accepted for both private and commercial berthing agreements at no extra charge.
- Post-dated cheques must be written clearly and always dated with the 1st of each month due.
- The first (1st) cheque should be dated for the current date, followed by five (5) more cheques every two (2) months after.
- AED 500 will be charged for every cheque that is either bounced, recalled, or replaced.

# BERTHING TERMS AND CONDITIONS

## VISITOR BERTHING

- All rates quoted are in AED and are inclusive of 5% VAT.
- Catamarans and house boats are charged at 1.5 times the standard rate.
- The above rates are subject to a 20% surcharge for all commercial vessels or vessels undertaking commercial activities such as yacht sales or brokerage.
- Berth fee is determined upon size of vessel.
- 50% discount applies on the daily visitor rates for vessels staying for four (4) hours or less.
- Four (4) hours complimentary berthing is provided for vessels using Muse Social House or Clubhouse.
- Vessel size is the overall length including tilted outboards, bowsprits and swim platforms as stated on the boat registration or measured by Royal Yacht Club of Ras Al Khaimah.
- Berth bookings must be made a minimum of twenty-four (24) hours in advance and are subject to berthing availability.
- Visiting vessels must provide Royal Yacht Club of Ras Al Khaimah with all current required vessel and vessel owner documents, a minimum of twenty-four (24) hours in advance.
- The maximum duration for visitor berthing is three (3) months, after which the six (6) months or twelve (12) months berthing fees will be applicable, subject to berthing availability.
- Visitor berthing is inclusive of utilities, for a maximum duration for visitor berthing is three (3) months. After this period utility consumption (power and water) is metred and charged monthly based on consumption, as per FEWA rates and service charge.
- All rates, charges and fees, includes increases in fees made by government or municipal department charges, are subject to change at Royal Yacht Club of Ras Al Khaimah's discretion.
- Berthing fees, terms and conditions are subject to change at Royal Yacht Club of Ras Al Khaimah's discretion.

## SLIPWAY PASS

- All rates quoted are in AED and are inclusive of 5% VAT.
- The six (6) month slip way pass provides complimentary use of the slipway and launching services, 20% discount on F&B at Muse Social House and 15% discount on F&B at Clubhouse.
